# Barbara's imprint is all over Ottawa

Barbara McInnes worked tirelessly to enhance philanthropy in Ottawa and beyond for almost four decades. She built community with exceptional dedication. A leader in philanthropy and community development, Barbara was an inspiration to many. She brought energy and excitement, balanced with wisdom and intelligence to every endeavor she was a part, always with good humour and a generosity of spirit. The legacy that she built will continue to live on throughout our city. Barbara was a force for good. She developed new avenues and partnerships that enabled generous citizens to invest in their community.

A woman of energy, verve and vision, Barbara served her community, all while spreading her upbeat brand of civic-mindedness.

Perhaps even more significant than her accolades, incredible career and service achievements is how Barb inspired, supported and mentored people throughout her career. Barbara launched many novice donors on their philanthropic paths; coached and mentored a generation of community leaders; supported countless organizations and represented Ottawa and Canada on national and international stages.

She was tireless in her devotion to making Ottawa the best it could be.

Barb might have been petite, but she was never short of vision and leadership. While the Ottawa Community Foundation was a central part of her legacy, she also served as a founding director of Community Foundations of Canada for 13 years. Her international interests include extensive work with the US-based Council on Foundations with memberships on their Leadership and Strategic Planning Committees, as well as the Trans-Atlantic Community Foundation Network.

In recognition of the breadth and depth of her work at all levels, Barb was inducted as a Member of the Order of Canada in 2010.

An enduring memory of Barbara for many is of her often dancing down the hallways of offices in Ottawa with joy and abandonment.

### Barbara McInnes, C.M. September 29, 1943 – July 1, 2021

Barbara McInnes helped her father Alastair Gamble, and Gordon Henderson launch the Ottawa Community Foundation in 1987, then took over its leadership four years later and built it into one of Canada's most highly respected and largest community

foundations, with assets of \$100-million and grant disbursements of over \$6 million annually by the time she retired in 2014. Barbara guided the organization for 27 years, building it as a leader among Canada's 191 community foundations.

Barbara was a founding Board member of Community Foundations of Canada and served on its Executive Committee for 13 years. She mentored six new Canadian Community Foundation CEOs during their first year on the job. She worked extensively with community foundations in North America and Europe, freely sharing her expertise and knowledge of organizational development and donor engagement.

Internationally, Barbara was a member for 13 years of the Transatlantic Community Foundation Network, dedicated to assisting the growth of community-based philanthropy in Europe and Mexico. She was also actively involved on several committees of the Council on Foundations in Washington, D.C. including the board's strategic planning committee.

Barbara was a frequent speaker locally, nationally and internationally on various philanthropic and community-based topics. She contributed a chapter to *Local Mission: Global Vision*, published in September 2008 by the Foundation Centre in New York and now available in four languages.

Barbara retired as President & CEO, Community Foundation of Ottawa in February 2014
